CHRIST CHURCH'S STEWARDSHIP SCHEME

As a church community, we as individuals contribute towards meeting the mission of Christ Church through the generous donation of both our time and money. One of the primary opportunities to do this is through the stewardship scheme. This allows us to plan our finances efficiently and share the costs of running the church across the congregation, while giving us all the opportunity to share our resources with one another and with God.

Despite rumours to the contrary, we do not receive any money from the Church of England or the government. We need to fund the running costs of our church ourselves and we always aim to cover our daily running costs through the planned giving of our own congregation. There are also additional costs for which we have special funds, for example the fund to pay for improvements to the church buildings, including the repairs to the wall at the front of the church grounds.

We continue to be prudent in our spending and maintain tight financial controls. However, to continue to cover our costs and grow our mission to make a difference in Merton and the world, this requires a continued commitment from all of us.

The Bible suggests giving away 10% of our net income. The Church of England suggests to individuals that we give 5% of our net income (after tax, NI and pension contributions) to the church and a further 5% to support other charitable giving.

The table below gives examples of the recommended donations based on income:
